3. Police Matters (1 min)

RJ spoke to PC Reed and Inspector Paul Crawley with regards to reports sent to OSMCC on a regular basis, for inclusion in our monthly meetings – RJ to meet with Insp Crawley mid March.

7. Highways and Planning (10 min)

(Planning Working Party to present their report)

7.1 It was noted that a second request with regards to the Solar panels at Fairwater Farm, still no response – RJ to update

There has been works in the area, development is ongoing.

7.2 St. Edeyrns 1020 houses - update

DR made enquiries, planning department spoke to the developers no definite proposals as yet.

Church Road – possible closure – no proposals as yet, there will be a public meeting, but no dates given.

7.3 M4 new road proposals, there will be a meeting in Castleton Village Hall – 23rd and 24th March 2016 11am – 7:30 pm, drop in session.

8. Finance (10 min)

(RFO to present financial report)

The RFO stated that the report has been sent in the normal format showing several annual subscriptions due reflecting the approach of the year end. In addition, RFO was expecting invoices from our Insurance Company representing the annual premium together with one reflecting the cost of recent tree work at St Edeyrns Church and the Ty Winch playing fields. Each amount will be in excess of £1k and payment will be made prior to year-end and in line with cash flow projections. Four small income receipts have been received in the past 2 days, including the waste management refund of £54

It was resolved: all agreed for payment

The RFO stated he had attended a meeting at Atlantic Wharf with Cllrs James and Rees regarding the possibility of acquiring either the freehold of the Village Hall or the long term extension of the current lease. It appears that the Estates Department have to liaise with the Parks Department, so any decision could be several months away. RFO continued by advising that moles were active at the Playing Fields and has employed a mole catcher to resolve the problem. Redecoration estimates for the Village Hall will be available next month.

Potholes

The Eastern Avenue has been reported, a schedule of pothole refilling has been started with £300,000 in the budget for these repairs, unfortunately residential small roads get pushed back, along with rural roads.

Litter

Bags to be collected in the Ton, still not done, contacted Chief office who gave assurance to have this looked at.

Endless reports with regards to litter, noted surrounding areas are particularly awful.

Llandaff Square

Still ongoing, the area has not been cleared up.

St Mellons School

£250,000 grant for extension, office space, meeting rooms.

Eastern High School

Grant awarded to improve the school.

Litter pick

It was noted that a date is to be organised to litter pick for the Queen's 90 birthday.

It was resolved: Saturday 4th June to meet at Coach House car park at 10:30am

It was noted that Cllr Georgina Phillips did not submit a report.
