6. Finance (10 min)

(RFO to present financial report)

The RFO has not yet received the Section 106 letter relating to the Hall roof overhaul and understands further monies are also available for an upgrade to the playing fields Pavilion. An update should be available for the next meeting. Similarly annual tree update reports have been received and o/s work reviewed next month.

Both the Clerk and RFO met up with the Internal Auditor following the last Council meeting and the RFO will arrange to submit the 2018-19 audit papers in the following weeks. The RFO has taken part in a series of HMRC webinars currently being run emphasizing 2019—20 tax changes and requirements.

6.1 Grass Maintenance Tenders

The RFO reported that the grass maintenance tender had to be extended following the withdrawal of the lowest tender and two new tenders have been received. A third tender is now awaited.

It was noted 3rd tender had gone into liquidation.

DM proposed that the RFO to return to the two companies and ask for a re-quote to cover a 2-year period, noted to also put the 2-year quote out to tender—to defer to next meeting.
