Highways have forwarded this issue to Drainage Client/Flood Alleviation team who will investigate further, and they will decide if any improvements can be undertaken as per the Clerk's request.

The RFO had forwarded the September 2019 bank reconciliation to Councillors together with the hall roof update and receipt of the Section 106 monies. The hall roof has now been completed, the guarantee received, and the final payment made to the builder. Council approved a number of cheques requiring approval including the annual website charge for £300 and £646 relating to Council building regulation fees for the pavilion improvements. Estimates are being obtained for the annual electric hall test. The RFO stated 2020/21 budget has to be produced in the next two months. RFO requires clarification regarding the availability of either Section 106 or grant monies next year as there is a need to carry out improvements at the Pavilion and Hall. It was agreed to hold a finance meeting prior to the next Council meeting.

11. Police Matters

Between the 1st September and 7th October 2019 there were a total of 4 crime occurrences. there were a total of 13 South Wales Police Occurrences for the Old St Mellon's area.

Operation Red Mana is has been running during the summer months and continues to run throughout the city. This relates to our constant battle with off road motorcycle nuisance. We are aware Old St Mellon's is a particular victim of this and as such a joint collaborative approach with the council is being undertaken which will commence soon. It is worthwhile stating that the police are limited in their approach to off road bikes, primarily from a health and safety point of view, however I have requested that the St Mellon's area is a priority location for the operation.
